INDEMNITY & NON-DISCLOSURE

hereby:

1. Acknowledge that Warner Beach South Neighbourhood Watch, (WBSNW), is not a legal person or entity and functions within the guidelines as provided and set out in the KwaZulu Natal Provincial Constitution and Code of Conduct for Neighbourhood Watch Structures.
2. Acknowledge further that WBSNW is a non-profit voluntary association, not a corporate entity established by or under any law and that it does not have a juridical personality and as such does not have powers of whatsoever the nature might be in law to act or to be acted upon;
3. Acknowledge that I have read the Constitution of WBSNW and that I fully understand the terms thereof and will abide by them;
4. Acknowledge that I have read the Code of Conduct of WBSNW, that I fully understand the terms thereof and accept that the Code of Conduct of WBSNW may be amended from time to time and such updates will become binding on myself as a member of WBSNW when updated;
5. Acknowledge that I have voluntarily chosen to be a member of WBSNW.
6. Acknowledge that I have voluntarily chosen to be a patroller and as a patroller I do not acquire any special legal powers or rights beyond that of a normal citizen of South Africa.

7. Acknowledge that WBSNW will not be responsible for civil and or criminal actions that are perpetrated by me as a member of the neighbourhood watch, nor responsible for defending civil and or criminal actions brought against me as a member of WBSNW whether they are intentional acts, omission, negligence on or for any other reasons;
8. Acknowledge that any and all criminal and civil actions that are instituted against a member of WBSNW will be against the member concerned and not the Neighbourhood Watch.
9. Acknowledge that as a member of WBSNW I act in my own capacity as an individual in all my decisions and actions and that liability will be in that capacity and therefore indemnify WBSNW against any actions committed or omitted by me as a member of WBSNW, I explicitly indemnify the aforesaid, being WBSNW, its committee and all other WBSNW members and related parties and associations that WBSNW is affiliated with, in respect of any criminal or civil liability, against any costs, claims, suits or damages howsoever arising directly or indirectly from any intentional act, omission or any negligence of for any other reason on my part;
10. Acknowledge that as a WBSNW member I may not divulge any confidential or privileged information that I may have acquired as a result of my membership of WBSNW, this includes photo's, documents, messages and conversations had or overheard. Disclosure of such information could result in my immediate suspension as a member of WBSNW, pending a full investigation and final decision on the matter by the EXCO, who's decision will be final and binding on me and could lead to my permanent expulsion from WBSNW and possible criminal charges;
11. Acknowledge that WBSNW has no insurance that covers me in anyway whatsoever.
